

REFINERY29 MAD CHATTER SWEEPSTAKES 2018

Official Rules

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID IN ALASKA, HAWAII, AND RHODE ISLAND AND WHERE PROHIBITED BY LAW.

This Sweepstakes may only be entered in or from the forty-eight (48) contiguous United States (excluding Rhode Island), and the District of Columbia and entries originating from any other jurisdiction are not eligible for entry. This Sweepstakes is governed exclusively by the laws of the United States. You are not authorized to participate in the Sweepstakes if you are not located within the forty-eight (48) contiguous United States (excluding Rhode Island) and the District of Columbia.

6. WINNER NOTIFICATION: On or about the respective Random Drawing Date listed in the Chart above, the potential Sweepstakes winner will be notified.
